The undersigned, having been directed, hereby calls upon eligible government ministries/divisions and access entities to submit loss and damage Funding Requests (FRs) (Project Proposals) to the Secretary, Economic Relations Division (ERD), Ministry of Finance, who has been designated as Bangladesh's National Focal Point for the FRLD.

Funding Requests (FRs) must be prepared using the designated template and in accordance with the guidelines circulated under the Barbados Implementation Modalities (BIM). Specifically, the Terms of Reference (TOR), FR Template, Letter of Endorsement (LoE) Template, Guidance for Preparing FRs, Access Entity Information, and the Policy on Oversight Fee can be accessed here: <https://www.frlld.org/nodebim>. While updated templates and guidelines are available on the FRLD website, some recent documents are attached here for your convenience.

Once received, all Funding Requests (FRs) will be duly and rigorously scrutinised in accordance with relevant FRLD policies, plans and guidelines, and eligible Funding Requests (FRs) will be issued a Letter of Endorsement (LoE).

Please note that Funding Requests (FRs) must be submitted in both soft and hard copies. Soft copies can be submitted here: secretary@erd.gov.bd and un9@erd.gov.bd. FRs submitted in either format will be treated as received in the first instance. FRs received after **Tuesday, 02 June 2026**, will not be considered for the ongoing BIM round, whose submission window will close on 15 June 2026.
